**ORAL ORDER**

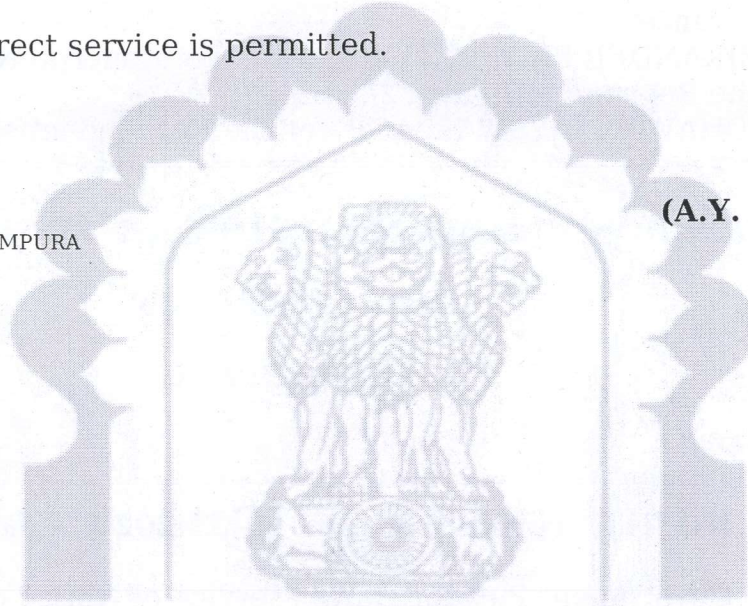
1. **NOTICE returnable on 18-03-2020.** Learned Assistant Government Pleader waives service of Notice on behalf of the respondent-state.
2. Learned Advocate for the petitioners submitted that electric line is being laid down by private company, which is in contract with the respondent No.1. One of the conditions, condition No.6 of the contract between the respondent No.6 – Private Company and respondent No.3 appears to be burden of the contractor to get clearance from Village, farms, revenue / private / Gauchar / Forest land and etc. throughout the route of transmission tower line at own cost and risk. It is

submitted that despite this, being burden of the respondent No.6, there does not appear to be any order of any authority including any authority under the provision of Telegraph Act to permit the respondents to lay out the electric transmission line.

Direct service is permitted.
