KP Group joins hands with Malaysia's SRAM and MRAM Group



KP Group has partnered with Malaysia's SRAM and MRAM Group, which has a global presence with more than 35 partners across the world. KP Group Chairman & Managing Director Dr. Faruk Patel signed an agreement with SRAM and MRAM Group Chairman Dr. Sailesh Lachu Hiranandani at the latter's office at Minara Exchange in Kuala Lumpur, Malaysia.

As per the agreement, SRAM and MRAM Group will infuse USD 152 million (approximately Rs. 1,262 crore) into KP Group entity KPIG Energia Pvt Ltd. Accompanying KP Group CMD Dr. Faruk Patel on the occasion was CFO Salim Yahoo.

The agreement with enhance the company's scale and enable it to work on multiple projects simultaneously. It is worth noting that KP Group's solar power company KPI Green Energy Limited and wind power company KP Energy Limited have completed 1.1 GW of renewable

energy projects so far, while orders of 2 GW are in the pipeline.

As of August 28, 2023, the combined market cap of both companies was Rs. 4,737 crore. With the company's business empire touching Rs. 10,000 crore, the Group aims to execute 10 GW projects by the year 2030.

SRAM and MRAM Group is a 40-year-old group with 35 branches in five countries, including India. Its services and solutions span oil & gas, cybersecurity, water and waste management, airports, agribusiness, infrastructure management, information technology, and more. It is a global conglomerate with eight international alliances and 10 group companies.

It is noteworthy that the agreement with SRAM and MRAM Group is KP Group's second international MoU. Earlier, the Group had signed an agreement with UAE-based Tristar Transport for green hydrogen development

KP Energy receives NoA for 464.10 MW BoS package from NTPC REL for wind energy project in Gujarat

KP Energy Limited has achieved a significant milestone by receiving a Notification of Award (NOA) from NTPC Renewable Energy Limited (NTPC REL) for a 464.10 MW Balance of System Package. This package is part of an Inter-State Transmission System (ISTS) Connected Wind Energy project in Gujarat.

KP Energy clinched the contract from NTPC REL, a subsidiary of NTPC, through a rigorous and

highly competitive bidding process, reaffirming its excellence in the renewable energy domain. The project falls under the company's Captive Power Producer (CPP) business segment.

Under the contracts, KP Energy will provide a comprehensive suite of services, including Engineering, Procurement, Construction, and Commissioning (EPCC). These services encompass the acquisition and transfer of land for the project, the supply of all necessary equipment for the balance of plant, and the provision of various services related to unloading, storage, on-site handling, installation, insurance, civil and allied works, integration into the grid, testing, and commission-

Additionally, the company will be responsible for the operation and maintenance of the



contract scope for three years, ensuring its optimal performance and reliability. As per the contract, the project is slated to be completed within 21 months from the date of the NOA.

Commenting on the development, Dr. Faruk G. Patel, Chairman and Managing Director of KP Group, said they are thrilled to receive the Notification of Award for the vital project from NTPC REL. He said that the award underscores their strong presence in the renewable energy sector and their expertise in the timely execution of challenging projects. He further said that the project reflects the trust clients have in KP Group's project execution capabilities. He reiterated KP Group's commitment to delivering high-quality renewable energy projects that contribute to India's green energy goals and promote a cleaner and greener future.









KPI Green Energy wins GUMNL tender for 240 MW solar power project

In a huge boost to its ambitious growth targets, KP Group's NSE and BSE-listed entity, KPI Green Energy, has emerged as the winner in the bid invited by the Gujarat Urja Vikas Nigam Limited (GUNVL). The company participated in the competitive bidding process for the GUVNL project in July. Following the reverse

e-auction process, KPI Green Energy successfully bid for a base capacity of 100 MWAC (120 MWP) and as a part of the green shoe option, proposed an additional 100 MWAC (120 MWP), thereby securing the full quoted capacity of 200 MWAC (240 MWP) grid-connected solar PV project.

The power purchase agreement (PPA) with GUVNL will be executed after approval is obtained from the Gujarat Electricity Regulatory Commission (GERC). KPI Green Energy shares rose following the tender win and jumped two per cent on August 4.

KP Group inks agreement with MAHAPREIT



KP group has entered into a Memorandum of Understanding with Mahatma Phule Renewable Energy and Infrastructure Technology Limited (MAHAPREIT), a subsidiary of MPBCDC, a government undertaking of Maharashtra. The MoU was signed by three group companies, viz. KPI Green Energy, KP Energy, and KP Green Engineering Pvt Ltd. It was announced on August 16.

Under this agreement, KP Group has been appointed as a knowledge partner to MAHAPREIT, offering valuable assistance in overcoming initial challenges by designing and formulating a comprehensive blueprint for project-specific strategic planning. Furthermore, the KP group will provide dedicated support in operational and control management aspects throughout the entire project lifecycle.

KPI Green Energy was awarded a 145.2 MW Wind-Solar Hybrid Project by Ayana



KPI Green Energy has received a Letter of Intent (LOI) for a 145.20 MW wind-solar hybrid power project from Bengaluru-based Ayana Renewable Power Four. The project is scheduled to be completed in financial year 2024-25.

KPI Green Energy will build the project comprising 145.20 MW wind and 50 MW solar components in the state of Gujarat. The project falls under the company's 'captive power producer' business segment, stated KPI.

The company's scope of work includes land acquisition, design, manufacturing, supply, construction, erection, testing, and commissioning for the balance of the plant, as well as facilitating power evacuation facilities and securing the necessary approvals and permits for the project.

KP Group announces excellent results in the first quarter:

Net profit jumps 51% to Rs. 48.5 crore

KP Group registered a stellar financial performance in the first quarter of the financial year 2023-24 with an exceptional profit after tax and growth in revenue.

KPI Green Energy Limited, the flagship solar energy company of KP Group, reported an income of Rs. 190.6 crore during the April-June quarter of FY 2023-24, representing a growth of 55% over the income of Rs. 122.8 crore in the corresponding quarter of the previous year. The company's cash profit for the quarter was Rs. 50.7 crore, registering a substantial growth of 61% over the cash profit of Rs. 31.5 crore in the same quarter of the previous financial year. KPI Green Energy's profit after tax for the guarter jumped 50% to touch Rs. 33.3 crore, up from Rs. 22.2 crore in the same quarter of the previous financial year.

KP Energy Limited, the KP Group's wind energy company, also made a significant contribution to the excellent numbers for the first quarter. It registered a cash profit of Rs. 15.7 crore, thereby marking a growth of 32% from Rs. 11.9 crore in the same quarter of the previous year. The profit after tax soared by 52% to Rs. 15.2 crore from Rs. 10 crore.

Collectively, both entities have been displaying a remarkable growth trajectory and continued the same in the first quarter. Combined income for the April-June quarter of 2023-24 grew by 23% to Rs.304 crore from Rs. 24.78 crore in the corresponding quarter of the previous fiscal. Cash profit witnessed an impressive upswing of 53%, reaching Rs. 66.4 crore from Rs.43.4 crore, while the profit after tax surged by 51% to Rs. 48.5 crore, compared to Rs.32.2 crore in the previous year.

KP Human strives to bridge the education gap

Teaches English-Hindi to over 4,000 children before school

KP Human Development Foundation distributes free English-Hindi learning books to 44 schools of Nagar Prathmik Shikshan Samiti in Rander zone and Beat-4.



As a part of its commitment to promoting education in society, KP Human Development Foundation has initiated an effort to improve the understanding of English and Hindi languages among children in schools managed by the Surat Municipal Corporation's Nagar Prathmik Shikshan Samiti. Under the initiative, the Foundation has distributed free English-Hindi learning among more than 4,000 students of 44 schools in Rander Zone and Beat-4.

The state government organises the Shala Praveshotsav (School Enrolment Drive) every year to enrol young children in schools and lay the foundation for their bright future. Last year, the state government expressed the thought of inculcating an understanding of English and Hindi among young children from the very beginning of their academic journey. In response to the same, KP Human Development Foundation initiated the courses in Nagar Prathmik

Shikshan Samiti School numbers 105 and 149, which it has adopted. Books were distributed free among the children.

The initiative has now been expanded to 44 schools of Nagar Prathmik Shikshan Samiti in the Rander zone and Beat-4 with the free distribution of English-Hindi learning books to over 4,000 children studying in the first and second standards.

The paintings remained on display at the exhibition for four days. Dr. Faruk Patel also announced that visitors willing to buy the paintings would have to pay 15% more for the paintings for the benefit of the prisoners. It is worth noting that art lovers from the city purchased seven paintings at the higher cost and nine paintings at the original cost. KP Human Development Foundation will use the paintings for gifting purposes during festivals.



Welfare initiatives in Lajpore Central Jail by KP Human

- For the last five years, provision for food that can be consumed during fasts in the holy month of Shrayan.

Centre at Memon Colony, for the benefit of students aspiring to appear in UPSC, GSPC and other competitive exams. The Foundation has gifted the high-tech library to the Baroda Muslim Doctors Association.

The library was inaugurated on July 27, 2023, by KP Green Engineering Pvt Ltd's CEO Moinul Kadwa and KP Group's HR

Director Hassan Faruk Patel. KP Human Development Foundation's Director Afraz (Raja) Shaikh oversaw the development of the library. The library is equipped with furniture, adequate lighting, air conditioning, security system, wiring, one desktop, and seven tablets for online reference.









KP Group has earned a name for its commitment to innovation. The company has developed a robot for cleaning the solar panels. It has set up a new startup with the name "KPI Green OMS" and hired a team of robotic engineers for the same. A factory has been established in Ahmedabad for developing solar panel cleaning robots. Robotic cleaning of solar panels is being undertaken at KP Group's nine solar sites at Sudi, Ranada, Samoj, Vedchha, Bhensli and Vagra on a trial basis. Under the leadership of KP Group CMD Dr. Faruk Patel, robotic engineers Jaid Kesrani, Ravindra Rehear and Harsh Mewada have been tasked with creating and deploying as many as 90 robots for panel cleaning at various sites. The robot's battery lasts for three years. With a backup battery, the robots can be deployed for six hours at a stretch.

What are the benefits of robotic cleaning?

- The speed of cleaning has increased. A robot can clean 40 solar panels. every minute. Solar panels of up to 700 KW can be cleaned in an hour.
- Cleaning can be accomplished easily with less lower and time savings. Until now, ten employees could clean solar panels of 1.5 MW in a 6hour shift. Moreover, the cleaning had to be undertaken during night hours. As a result of the deployment of robots, only two employees are needed for monitoring and shifting the robots. Cleaning is also possible during day time now and that too in just one-fourth of the time.
- There is a marked saving in water required for cleaning the panels. When cleaning was done manually, each panel required around 3 litres of water. With robots, there is no need of water for cleaning. This is especially beneficial in sites prone to water shortage. Cleaning was also a challenge at many sites due to the availability of only hard water. In such cases, water tankers were required to be ordered. The use of robots for cleaning has helped the company address many such challenges.

FACILITY Enhanced facilities for staff: two buses allotted for Dabhasa factory employees

The KP Group has allotted two buses for transporting the employees of its flagship company KP Green Engineering Pvt Ltd's galvanising and fabrication factory at Dabhasa village in Vadodara's Padra taluka. The majority of the factory staff lives in Vadodara city or surrounding areas and they were forced to spend significant sums on their transport to and fro work. Then, there was also the issue of safety in personal transport. To address these multiple issues and in line with KP Group's commitment to employee welfare, two buses have been acquired for transporting the employees to and from work. The suggestion to purchase the buses was made by KP Green Engineering's CEO Moinul Kadva. The buses ensure that the staff reach the factory together. Travelling by bus has greatly enhanced their safety while commuting, and helping them save thousands in costs they were incurring on fuel and travel earlier. Moreover, the shift will result in reducing carbon emissions. One of the buses has been made operational so far, which is being used by 26 employees to travel to and from Vadodara. Sixty-six employees will benefit once the second bus route is set.

KP Group has always been employee-friendly. Whether it is free meals or other matters related to their welfare, the group does not make any compromise. To ensure that the employees are served pure and high-quality food, KP Group CMD Dr. Faruk Patel and his core team also eat along with the employees. The same food is served to the employees and the senior management. These are some of the reasons that have made KP Group a "Great Place to Work".

Annual General Meetings of KPI Green Energy and KP Energy held

We have emerged as national players, and will achieve growth targets before the deadline: Dr. Faruk Patel

The 15th Annual General Meeting of KPI Green Energy and the 14th AGM of KP Energy were organised. Addressing the shareholders, Chairman & Managing Director Dr. Faruk Patel spoke about the companies' commitment, dedication, and unbelievable growth. He said that KP Group has become a key player in the renewable energy sector not just in Gujarat, but has emerged as a national player. He said that with the receipt of contracts from NTPC, GUVNL, Ayana and other projects, the companies will achieve their growth targets much before time.



Just as our country has reached the moon and launched a solar mission, KPI Green Energy is also shining bright

Addressing shareholders of KPI Green Energy, CMD Dr. Faruk Patel said that shareholders who had placed their trust in the company have benefited a great deal. He said the company has issued 1:1 bonus shares and paid a 28.50% dividend. He noted that Crisil Rating has considered the company's performance to upgrade its rating to A-, while the company is now among the top 1000 companies in India. He said both achievements are a matter of pride. Referring to the Chandrayaan 3 mission, he said the country has reached the moon and has also launched its solar mission. KPI Green Energy is also shining bright. He expressed confidence that the number of projects the company has won will yield excellent performance in the future.

Dr. Faruk Patel said that Prime Minister Narendra Modi aims to make India a global

leader in renewable energy. He said KPI Green Energy will play a substantial role in helping the country achieve the net-zero carbon emission goal by 2070. He expressed happiness that the Almighty has selected them to ensure a clean environment for future generations and lauded the team for efficiently working in that direction.

Dr. Faruk Patel also mentioned KPI Green Energy's historic feat of installing seven wind turbines in the virgin site of South Gujarat as a part of its hybrid project. He informed that the company will undertake 380 MW hybrid projects and complete 894 MW projects by next year. He said the company has set a target of 1,000 MW projects by 2025, but expressed confidence that the target would be achieved before that. The company won a 240 MW IPP order from GUVNL and 145 MW CPP order from Ayana Renewable in June. The company's order pipeline stands at 541

MW. It has also received an order to install 17 wind turbines from Suzlon for 47.60 MW capacity. He said that in addition to being focused on business, the company also supports various social causes. He shared that the company has spent Rs. 8 crore until now on education, health and similar activities. He also spoke about the Prabhu nu Ghar project, the first-of-its-kind dedicated old-age home for the specially-abled in Bharuch. He said the company is spending much more on CSR than it is required for various humanitarian causes. He said that they are committed to moving ahead very quickly in business and service.

Company has achieved three-digit Profit After Tax: Salim Yahoo, CFO

Addressing shareholders at the KPI Green Energy AGM, the company's Chief Financial Officer (CFO) Salim Yahoo said the company had achieved revenue growth of 179% in the financial year 2022-23 as compared to the financial year 2021-22. The revenue had increased from Rs. 231.52 crore to Rs. 647.03 crore. He informed that the Profit After Tax had gone up from Rs. 43.25 crore in FY 2021-22 to

Rs. 109.63 crore in FY 2022-23. The cash flow had improved from Rs. 102.38 crore to Rs. 159.39 crore.

He noted that the company had delivered 42.51% returns to shareholders over the previous year. He said that the country aims to achieve net-zero carbon emissions by 2070 and generate 500 GW of renewable energy by 2030. He said the company is playing a vital role in achieving

these goals. He shared that coal-based power accounts for 44% share of the Indian power sector, petroleum and other liquids 24%, traditional biomass and waste 21%, and natural gas 6%. Renewable energy capacity is 177 GW but there is a huge scope for growth in this space, which augurs well for the company. He expressed his sincere gratitude to shareholders and investors for their faith in the company.

Our growth was double that of the previous year: Shaheedul Hasan, COO

"A winner is a dreamer who never gives up" said the company's Chief Operating Officer (COO) Shaheedul Hasan at the AGM, quoting the great Nelson Mandela. He told shareholders that the company has commissioned an additional 147 MW capacity in the financial year 2022-23. The cumulative capacity has increased from 165 MW to 312 MW, i.e. by 90%. He noted that the company had created history by installing a 26.1 MW (16.1 MW wind and 10 MW solar) hybrid power plant in South Gujarat, and opened new growth avenues for wind energy in the region.

The COO said that the IPP generation had gone up from 10.4 crore to 14 crore, registering a growth of 40% in the year. The company's power evacuation capacity is

846 MW. Under IPP-CPP, the company has completed orders with double capacity. The company has a total of 24 project locations including eight projects of 66 kv capacity and 16 projects of 11 kv. He informed us that five new locations have been added, which include Sarod, Muler and Ochhan for 11 kv and Samoj and Bhavnagar's Bhungar (hybrid) for 66 kv. He also informed shareholders that KPI Green Energy has achieved a 20% increase in power generation by installing solar trackers as a part of a pilot project. He said that the trackers would be installed in every IPP project from now on. The company has tied up with a German technology company. He shared that the company has also initiated a pilot project for the waterless robotic cleaning of solar panels.

Work has also been started to create a Centralised Monitoring System (CMS).

During the AGM, the company's independent director Venu Birappa presented a broad scenario of the renewable sector and shed light on the state and central governments' plans for the renewable energy space.

The company's non-executive director Bhadrabala Joshi presided over the AGM. Company Secretary and Compliance Officer Rajvi Upadhyay shared the relevant information with shareholders. KPI Green Energy has received the commissioning certificate from the Gujarat Energy Development Agency (GEDA) for its 4.10 MW wind-solar hybrid power project at Samoj village of Bharuch's Jambusar taluka. The project comprises 2.10 MW wind and 2MW dc solar capacity. It has been established under the Gujarat Wind-Solar Hybrid Power Policy 2018. The electricity generated by the plant is sold to commercial and industrial customers.

It is noteworthy that KPI Green Energy has opened new avenues for wind energy in South Gujarat by installing and successfully running the first wind turbine in the region. The achievement has come as a surprise for the larger wind energy players. The company has installed seven wind turbines as a part of the project and that too within a brief period of just four months.

future requirements, the company is also going ahead with its plans to set up a new fabrication and galvanising plant near Matar village.

The company's current production capacity is 54,000 metric tonnes per annum. It has approvals for 400 & 220 kv transmission lines from GETCO and 220 kv lines from MSETCL. The company also handles the operation and maintenance of 2,000 km of optical fibre cables.

KP Green Engineering employees' smart work through innovation



Employees of KP Group's flagship company, KP Green Engineering (formerly known as KP Buildcon Pvt Ltd), have taken an innovative route to smart work at the Dabhasa factory. Earlier, fabricated and galvanised heavy goods of as much as 15 tonnes had to be shifted manually and with the help of an overhead crane. In case the crane was engaged in other work, the shifting of goods remained pending. The shifting work is now being carried out with the help of remote-controlled trolleys. Employees have built six such trolleys using their own ingenuity and creativity. The use of trolleys has resulted in speedier work, leading to time savings. The employee who thought of the innovative idea is maintenance executive Karamchand Patel, who has

been working at the site for eight years. The idea struck him during the Covid-19 days while talking with the CEO Moinul Kadva about the challenges in shifting of goods.

Karamchand says that he and four other employees developed two trolleys during the very first nationwide lockdown. The trolley, comprising a 10 HP generator, control panel, reverse-forward panel, and motor gearbox, is operated using a remote control. Subsequently, the employees developed four more trolleys. Tracks akin to railway lines have been laid out in the factory for the movement of the trolleys. The trolleys have been made at a negligible cost of Rs. 2 lakh but have resulted in tremendous ease in the movement of goods.
