

Work at Bullet Speed: KPI Global Infrastructure installs 3.8MW solar power plant at Bhimpura in just 21 days



KPI Global Infrastructure executed the work of a 3.8MW solar power plant at Bhimpura village of Bharuch's Amod taluka at lightning speed. You will be surprised to know that the solar power plant, which is spread over 11.27 acre, was installed in just 21 days. Work on the plant was originally supposed to begin in March, but was delayed because of the nationwide lockdown. All plans related to the plant were readied in the meantime, which allowed the work to be completed in a record time.

Under the guidance of CMD Mr. Faruk Patel and COO Mr. Shaheedul Hasan, the 79-member team led by Project head Mr. Rafik Burma completed the plant's installation and commissioning at an unbelievable speed to add another feather to the cap of KPI Global Infrastructure.

With the commissioning of the Bhimpura plant, KPI Global Infrastructure's Captive Power Project (CPP) capacity has touched 10MW.

The company has already signed agreements with Devika Fibre Pvt Ltd., Sanika Industries Pvt Ltd., and JPB Fibre for supply of clean power from the Bhimpura solar power plant.

It is noteworthy that the company is targeting 1,000 MW solar power capacity, including IPP and CPP, by the year 2025. If the pace of project execution can be maintained, the company will be able to reach the target much before that.

Largest 300MW capacity pooling substation installed in Gadhsisa project at kutch





KP Energy Limited is taking rapid strides towards tapping wind power. The company has completed the work on a pooling substation of 300MW (33/220KV) capacity in Gadhsisa village of Kutch, and activated the Extra High Voltage (EHV) line. The line is 73.334 km from Gadhsisa to Nirona Power grid. It includes 1.086 km multi circuit, 68.126 km double circuit, and 3.87 km single circuit line. The company had begun work on



the Gadhsisa-Nirona line in August 2018, and commissioned the same on October 1, 2020. We have been successfull in connecting 120 locations with the Gadhsisa substation. Earlier, the company had installed a 33/66 KV substation at

Dehgam(Porbandar). The EHV line of that substation was 12 km. In the coming days, the company is going to work towards completion of the Siddhpur site(Dwarka district) 252 MW plant.
